

**Quonochontaug Grange Fee Schedule**  
**Effective November 1, 2022\***

**One Time Event Usage Upper Level:**

- Four Hour Period: \$50 (1-4 hrs. during the following time periods)
  - 8:00 AM to noon or
  - Noon till 4:00 PM or
  - 1:00 PM to 5:00 PM or
  - 5:00 PM to 9:00 PM or
  - 6:00 PM to 10:00 PM or
  - 6:00 PM till midnight (additional \$10 fee)
- Eight Hour Period (two sequential 4-hour periods): \$100 (5-8 hrs.)
- Includes access to the Lower Level Restrooms
- Four Hour Period with use of AV equipment: additional \$20
- Eight Hour Period with use of AV equipment: additional \$30

**One Time Event Usage Lower Level:**

- Four Hour Period: \$40 (1-4 hrs.)
  - During the above time periods
  - 6:00 PM till midnight (additional \$10 fee)
- Eight Hour Period (two sequential 4-hour periods): \$80 (5-8 hrs.)

**Full Building Event Usage:**

- Four Hour Period \$90 (1-4 hrs. during the following time periods)
  - 8:00 AM to noon or
  - Noon till 4:00 PM or
  - 1:00 PM to 5:00 PM or
  - 5:00 PM to 9:00 PM or
  - 6:00 PM to 10:00 PM or
  - 6:00 PM till midnight (additional \$10 fee)
- Eight Hour Period (two sequential 4-hour periods): \$180 (5-8 hrs.)

**One Time Use of Kitchen Facilities:**

- In conjunction with a one-time use of the upper level: \$100 plus the above fee for full building event use.
- In conjunction with a one-time use of the lower level: \$100 plus the above fee for lower level event use.
- **For use of the refrigerator only**, in conjunction with a one-time use of the upper or lower level: \$30.00 plus the fee for the event space so used.

**Reoccurring Same Event Usage:** Fee to be determined on a case-by-case basis.

**Utilities Fee:** Determined on a case-by-case basis.

**Rental Fee Payment:** By check made payable to "Friends of the Quonochontaug Grange, Inc. (FOTQG)," shall be due, payable and delivered to the Quonochontaug Grange Rental Manager no later than at the time of booking of the scheduled use.

**Notice of Cancellation:** During the months June to September, a three (3) week notice of cancellation is required and during the other calendar months, a one (1) week notice is required, otherwise the rental payment will be forfeited. Should another party subsequently rent the space for the period(s) cancelled, the forfeited rental shall be returned.

**\*Note:** This Fee Schedule is subject to change. The fee for booked events will be charged the fee at the time of booking.
